#### 1. INTRODUCTION

This report includes the progress made in the IYFF+10, since 2016 to the end of 2018. It is an effort that tries to show the successes or achievements of the family farming organisations and the National Committees on Family Farming (NCFFs onwards) and platforms, in particular.

It also includes results achieved by other dialogue platforms (MTCP2, etc) and national and regional Family Farmers Organizations (FO).

The information presented is compiled in the database that was created to monitor the actions being carried out within the context of the IYFF+10.

It is based on 8 indicators that allow the progress of the IYFF +10 and its lines of work to be measured, thus accounting for the processes to achieve improvements in public policies in favour of Family Farming (FF). These 8 indicators were agreed by the IYFF+10 World Coordination Committee at its meeting in October 2017.

#### The 8 indicators are:

- 1. Number of new public policies approved.
- 2. Number of public policies implemented that contribute to improving FF.
- 3. Number of proposals for new public policies or political commitments in favour of Family Farming.
- 4. Number of political dialogue platforms in operation.
- 5. Number of farming organisations strengthened.
- 6. Number of actors involved in the IYFF +10.
- 7. Number of approved Guidelines (global, regional and national level).
- 8. Number of alliances established between research centres, universities, innovation platforms and agricultural organisations.

It highlights that, once the Decade of Family Farming Action Plan is established, the indicators could be readjusted, to better adapt to the actions contemplated in the Decade Plan. It is also important to point out that obviously the Action Plan will have a direct link with the Sustainable Development Goals (SDG).

It is also a report under construction, to which more information will be incorporated in the coming months and which will continue to be nurtured with the results communicated to us.

The data has been ordered in the following way: first by level (global, regional, national or local), followed by Region / countries (alphabetically) and finally by year (from most ancient to most recent).

It must be stated that there is a significant difficulty when it comes to having information and data on the issues that impact on the situation of women and young people.



### 1. Number of new public policies approved.

From the normative framework perspective, this indicator measures the number of public policies approved by governments or supranational organisations. This indicator refers to the regulatory framework, i.e. laws, regulations, standards, etc.

#### 5. Number of farming organisations strengthened.

Regional family farming organisations, such as ROPPA, PROPAC, AFA, PIFON, COPROFAM, PDRR, UNMAGRI continue their strengthening process also within the framework of the IYFF+10. The same is happening with many national family farming organisations.

The NCFFs are undoubtedly very important for strengthening organisations, as dialogue platforms in which more and more farming organisations are playing a leading role, leading Committees and/or their main actions. Currently there are more than 200 farming organisations of national scope represented in the NCFFs, which are constituted by hundreds of grass-roots organizations.

Although they are undoubtedly high-priority issues on the NCFF agendas, there are little more than 20 women's organisations directly present in the NCFFs, while there are scarcely six youth organisations present directly.

#### 6. Number of actors involved in the IYFF+10.

There is a very strong stakeholder involvement in the IYFF +10. Through their members, regional Family Farming organisations achieve significant participation of the main actors of the Decade of Family Farming, the family farmers.

In addition, there are more than 800 organisations represented in the 40 NCFFs and platforms that are fully involved in the IYFF+10 Decade.

In addition, the Campaign for the Declaration of the Decade was widely supported, with more than 450 entities joining the campaign.

#### 7. Number of approved Guidelines (global, regional and national level).

Various spaces for regional integration, NCFFs, farming organisations, etc. have carried out processes to agree on the fundamental requirements that can guarantee the adequate development of Family Farming, encouraging countries to generate favourable public policies for their consolidation as a sustainable agricultural model.

# 8. Number of alliances established between research centres, universities, innovation platforms and agricultural organisations.

The alliance between research centres, universities and agricultural organisations is still under construction. To achieve this, a collective action is being designed within the framework of the GFAR, with the participation of: COPROFAM, AFA, PIFON, PROPAC, ROPPA, Prolinnova, ISRA-BAME, INADES, CIRAD, University of Louvain, SOS FAIM, Agricord.

In addition, a presence from the world of research and education is important in the NCFFs. In particular there are 59 universities, research centres or education centres represented in the NCFFs: 28 in the African NCFFs; 30 from America and 1 from Asia.



#### **PROCESS**

This section referred to the processes aims to make visible all the continuous work carried out by the organizations to achieve important advances in public policies.

Advances in public policies are generally the result of processes that in many cases have been initiated by political dialogue platforms (CNAF and other dialogue platforms, by agrarian organizations or by governments.) Indicator # 5 Strengthening of FOs as something continuous throughout the process.

This is an exercise to relate the different indicators and show the steps that have been taken to reach advances in public policy. In some cases, the achievements have not been able to be implemented because of changing contexts.

Likewise, the achievements described by these processes are not exhaustive. This report is a tool in continuous modification according to the available information.
